- ☐ During the construction period: A construction license (which specifies the use of building and the use in connection with the manufacture and processing of the articles) and other relevant documents shall be attached. If the factory establishment permit is required before the construction of the factory, the factory establishment permit shall be attached.
- ☐ After the completion of the construction of the factory: those who have already reached the factory registration standard should submit the relevant documents such as the factory registration approval letter (indicating the lot number and the factory area); those who fail to reach the factory registration standard shall submit the Use Permit or the building certification documents (which specifies the building in connection with the manufacture and processing of the articles).
